Definitions

Licensure:

- Mandatory. Government Requirement.
- May also be called Registration or Certification by some states
- Requires Assessment Testing
- Sets MINIMUM, entry-level competence
- Goal: Protect public from incompetence

Definitions

Certification:

- Voluntary. Non-Governmental
- Requires Assessment Testing
- Sets Advanced Professional Standards
- Identifies & Recognizes Those Who are Performing at an Advanced Level
- Results in an Advanced Professional Credential

Definitions

- Certificate:
 - Voluntary
 - Not regulated or standardized
 - A prescribed course or curriculum with a Certificate of Completion at the end
 - May or may not include any testing
 - Not to be confused with Professional Certification

- Certified Nursing Home Administrator (CNHA) Exam established in 1978
- Brown University & LTCQ Study of 2000
- Independent Study of 2013. Published Soon
 - Both used Comparative Studies of Facilities with Certified vs. Non-certified Administrators

Evolution of Exam

- Early Stages
 - Multiple-Choice, Knowledge-Based Exam
 - Peer-Reviewed Simulated Exercise
- Current Model
 - Multiple-Choice, Knowledge-Based Exam
 - Two-Part Multi-Disciplinary Exam:
 110 General Administration Questions
 40 Facility-Specific Questions (SNF or AL)

Exam Structure

General Administration (110 Questions)

- 1. Resident Care (includes Clinical & Food Service) (26%)
- 2. Human Resources/Personnel Mgmt (16%)
- 3. Financial Management (20%)
- 4. Environmental Management (15%)
- 5. Leadership (24%)

Exam Structure

Nursing Home & Assisted Living (40 Questions Each Section)

- Resident Care (27%)
- Human Resources (15%)
- Financial Management (25%)
- Environmental Management (11%)


